Indemnification:

By participating as a vendor in the farmers' market, all vendors (including their agents, employees, contractors, and representatives) agree to indemnify, defend, and hold harmless the City of Springville, its elected officials, officers, employees, agents, and volunteers (collectively, the "City Indemnitees") and members of the Steering Committee from and against any and all claims, demands, actions, suits, proceedings, liabilities, damages, judgments, fines, penalties, losses, costs, and expenses of any kind or nature whatsoever, including but not limited to attorneys' fees and costs of defense, arising out of or resulting from, directly or indirectly: (1) any act or omission by the vendor, its agents, employees, contractors, or representatives; (2) the vendor's use of the premises or participation in the farmers' market; (3) the vendor's breach of any provision of this agreement or violation of any applicable law or regulation; (4) any personal injury, death, and/or property damage or any other damage caused in whole or in part by the vendors' negligence or intentional misconduct or that of its agents, employees, contractors, or representatives. This indemnification obligation shall apply regardless of whether such claims, losses, or damages are caused in part by the negligence of the City Indemnitees and/or members of the Steering Committee, provided that such indemnification shall not extend to the sole negligence or willful misconduct of the City Indemnitees and/or members of the Steering Committee. The vendor's indemnification obligations shall survive the termination or expiration of their participation in the farmers' market.

Applicant Statement: I agree to abide by the Rules/Guidelines of the Farmers Market at Springville's Market on Main and to obtain all applicable permits and licenses; to assist in the inspection of my crops by agents of the Farmers Market of Springville's Market on Main, Alabama Farmers Market Authority (where applicable) and the State of Alabama Department of Agriculture; to sell only agricultural products from my farm (where applicable); or to sell only products produced by myself and/or my employees. I further agree not to hold the Market responsible for any damage arising out of the sales of my products.
