TERMS AND CONDITIONS

1. Building Hours: Monday-Sunday 24 Hour Access

Office Hours: Monday-Friday 8:00 am - Noon and 1:00 - 5:00 pm

- 2. Members will be granted access to the wellness center by an app on their mobile phone or a key fob. TRC reserves the right to charge \$5 to replace lost or damaged key fobs.
- 3. All memberships are based on the date purchased. Payments are processed on business days only. Please drop payments in the drop box located at the front desk or give to the Director during business hours. If member chooses to pay by auto-debit, memberships will be prorated to the first of the month and then deducted on the 1st of every month following. \$25 charge for returned checks.
- 4. All members must use their phone app or key fob every time they enter the wellness center. DO NOT allow anyone to use your key fob or phone app to gain entry to the facility! When letting non-members in the wellness center, it is YOUR responsibility to ensure that the \$5 guest fee is paid (see #5). Violations of these rules will result in verbal/written warnings and/or suspension of your membership. Repeated violations may result in the loss of your membership.
- 5. Non-members: Use of the facility costs \$5/day paid at the time of entry for ages 14 & up. Use envelopes in the lobby or by entry door for payment completing all information requested. Non-members must follow TRC Wellness Center rules. Please note that failure to comply may result in consequences for members. (see #4)

6. Age Restrictions:

Under 14: Need adult supervision at ALL times
Cannot be left alone in tennis court area
Cannot use any exercise equipment or free weights

14-15: Need adult supervision to use exercise equipment and/or lift weights Family Membership Required

16-17: Eligible for High School Membership (see #7)
Cannot bring any guests under the age of 16

- 7. High School Student Membership—**MUST BE 16-17 years old**. Parents/Guardian must sign membership application taking responsibility for their student. *Please note rules 4 & 5*.
